Chittenden Oast, Golford Road, Benenden

Re-instatement of roof and walls post house fire. Alterations to windows on first floor South facing elevation. Alterations to front door and windows to ground floor North elevation. Alterations to velux windows to cat slide roof first floor north elevation.
