Hawthorn House, Dorothy Avenue, Cranbrook, Kent, TN17 3AY

Demolition of existing single storey garage and replace with new single storey extension; Creation of two parking spaces on existing driveway;

Demolition of existing conservatory to rear of property and replacement with single storey morning room under permitted development rights.

Hill View House, The Hill, Cranbrook.

Tree in a Conservation Area Notification:

Yew – Remove smaller lower limbs (up to 100mm diameter) to a height of approx. 4m; Sycamore – Pollard limbs back to the trunk.

The Parish Council recommends APPROVAL, subject to the views of the Tree Officer. Proposed by Cllr. Smith, seconded by Cllr. Cook and agreed.

# **CORRESPONDENCE:**

An acknowledgement to our suggestion of 'Badgers' had been received. To avoid confusion with a single house the Project Manager had submitted the following alternatives to the Street Naming department at TWBC: Badgers Wood, Badgers Copse or Badgers Mews. Members agreed that Badgers Copse would be the best option.

Cllr. Bunyan tabled the anonymous letter received regarding the planning breaches at Waypost Meadow, Golford Road. Members agreed that any enforcement action was the responsibility of the Planning Authority who were following due process in this case.
